## **CODE OF CONDUCT**

On being elected to the Board of Directors of The Delhi Golf Club, Dr Zakir Hussain Marg, New Delhi 110003, I shall conduct myself so as to meet the expectations of operational transparency to members while at the same time maintaining confidentiality of information in order to foster a culture of good decision-making.

## I Shall:

- 1. act in accordance with the Articles of Association of the Club.
- 2. act in good faith in-order to promote the objects of the Club for the benefit of its members as a whole, and in the best interests of the Club, its employees, the members and for the protection of the environment.
- 3. exercise duties assigned to me with due and reasonable care, skill and diligence and shall exercise independent judgment.
- 4. not achieve or attempt to achieve any undue gain or advantage either to myself or to my relatives, partners, or associates.
- 5. act objectively and constructively while exercising my duties;
- 6. exercise my responsibilities in a bona fide manner in the interest of the Club.
- 7. devote sufficient time and attention to my professional obligations for informed and balanced decision making.
- 8. not allow any extraneous considerations that will vitiate my exercise of objective independent judgment in the paramount interest of the Club as a whole, while concurring in or dissenting from the collective judgment of the Board in its decision making.
- 9. refrain from any action that would lead to loss of my independence.
- 10. where circumstances arise which make me lose my independence, I will immediately inform the Board accordingly.
- 11. assist the Club in implementing the best corporate governance practices.
- 12. seek appropriate clarification or amplification of information and, where necessary, take and follow appropriate professional advice and opinion of outside experts at the expense of the Club.
- 13. strive to attend all meetings of the Board of Directors and of the Board committees of which I will be a member.
- 14. participate constructively and actively in the committees of the Board in which I am chairperson or member.
- 15. strive to attend the general meetings of the Club.

- 16. where I have concerns about the running of the Club or a proposed action, ensure that these are addressed by the Board and, to the extent that are not
  - resolved, insist that their concerns are recorded in the minutes of the Boardmeeting.
- 17. keep myself well informed about the Club and the external environment in which it operates.
- 18. not to unfairly obstruct the functioning of an otherwise proper Board or committee of the Board.
- 19. pay sufficient attention and ensure that adequate deliberations are held before approving related party transactions and assure myself that the same are in the interest of the Club.
- 20. ascertain and ensure that the Club has and continues to have an adequate and functional vigil mechanism and to also ensure that the interests of a person who uses such mechanism are not prejudicially affected on account of such use.
- 21. report concerns about unethical behaviour, actual or suspected fraud or violation of the Code of Conduct.
- 22. acting within my authority, assist in protecting the legitimate interests of theClub, its members and its employees.
- 23. not disclose confidential information, including commercial secrets, technologies, advertising and sales promotion plans, unpublished price sensitive information, unless such disclosure is expressly approved by the Board or required by law.
